RULES AND PROCEDURES FOR CONDUCTING ELECTIONS

BOARD OF GOVERNORS AND EDUCATION COUNCIL

1. **Authority**

In accordance with sections 12(2) and 17(2) of the College and Institute Act, the Registrar is required to establish rules for the purpose of combuting elections for positions on the Board of Governors and Education Council. 6 Conduct of Candidates

To ensure fairness, integrity, and professionalism, candidates and their agents must conduct themselves in accordance with all relevant College bylaws and policies and shall abide by any election regulations and guidelines as established by the Chief Hections Officer: Failure to do so may result in disqualification

7. Hection Procedures

Hections will be conducted electronically.

- a) The Hection Page will be updated in January, or as needed throughout the year, and will include:
 - a The Hection Rules and Procedures
 - b. The anticipated annual election cycle indurling relevant dates and deadlines
 - c. The Hection Schedule ance confirmed by the Chief Hections Officer:
 - d All official nonination forms
 - e Information of upcoming elections, names of nominated Cardidates and biographies as appropriate
 - f. The name and contact information for the Chief Hections Officer.
 - g The names of the Hection Appeal Committee

Nominations

a) The nonination period will last at least ten business days.

- b) Nonination forms must include the signatures of the Candidate and three noninators. The noninators must be eligible to vote for the Candidate being noninated.
- c) Cardidates must signa declaration attesting to their eligibility and their willingness and ability to serve throughout their term
- d) Cardidates may submit a headshot type photograph and a 200 word biography with their nonination form
- e) Nomination forms should be submitted electronically prior to the specified time on the last day of the nomination period² and must be received by the deadline date and time stipulated
- f) A late submission of the photograph will be accepted. No changes or submission are accepted for the biography.

² Candidates unable to submit monimation forms electronically must make submission arrangements with the Chief Hections Officers prior to the dose of the nomination period

- b) The Hection Appeals Committee shall decide its own process, including whether they require any further information or if they wish to hear oral submissions prior to making their decision
- c) Decisions by the Hection Appeals Committee are final and will be communicated to the parties to the appeal in writing

9 By Elections

Should a seat become vacant, and the residual term of the vacancy exceed four months, a by election will be held and the successful Candidate will fill the remainder of the term. The by election shall be held at a time deemed reasonable by the Registrarin consultation with the President and the Board or Council Chair.

The Registrarmay delay cruefuse to conduct a by election if, in their judgement after consultation with the representative groups, it is deemed to be uneasonable or because the timing would exclude a significant portion of an affected representative group.

Appendix A - Excluded Positions

Under the College and Institute Act, the elected employee members of the Board of Governors and Education Council consist of "faculty" and "support staff" members. The following definitions are found in the Act for these representative groups:

"faculty member" includes an instructor; librarian, tutor; coursellor; research associate, program coordinator or other employee of the institution that a collective agreement between the bargaining agents, as defined in section 1 of the Labour Relations Code, for the institution and faculty members specifies to be a faculty member:
